How to Access Treatment for your Back Pain and Rehabilitation During the COVID-19 Pandemic

With the COVID-19 pandemic resulting in medical and other clinics closing, substantially reducing clinic hours or health providers suspending their practices, we recognize the difficulty that many are now facing in getting in-person care for your back pain. However, many patients are now contacting their health providers asking about getting a "virtual" appointments over the telephone or over platforms such as skype or face time for video-conferencing

While the difficulty in getting in-person care with your health provider may ultimately assist in the Province's efforts to manage the impact of the COVID-91 pandemic, it is still remains important for you to get either the right advice "virtually" from your health provider so that they may continue to support your ongoing care or treatment as warranted.

As you may already know, the Government of Ontario recently ordered the closing down of non-essential workplaces as of March 24, 2020. However, the List of Essential Workplaces https://www.ontario.ca/page/list-essential-workplaces includes under Section 58 "Health care professionals providing urgent care **including** dentists, optometrists and physiotherapists." However, this list is not exhaustive and includes other health providers such as chiropractors.

Also, this does not preclude the provision of healthcare services "virtually" either online by e-mail/delivery or through telephone or skype as long as you are a patient and your health provider already has a pre-existing relationship with you which would have included an in-person examination, plan of care and prior informed consent.

With a "virtual" appointment, your health provider may communicate certain information, give advice and recommendations as part of your ongoing care plan and informed consent. At the end of the day, connecting virtually, may be an effective way for your health provider to continue to monitor your health condition safely and provide continuity of care.

On the other hand, please bear in mind that what constitutes urgent/emergency care is largely dependent on your health provider's knowledge, skill and judgment in each case. During this COVID-19 pandemic, it may be that your health provider will have to weigh the value of an in-person appointment vs the risk when physically seeing a patient.

Dear Patient and Community

We continue to take all necessary precautions for the safety of our staff and patients. If you have travelled within the last 2 weeks, come in contact with anyone diagnosed with coronavirus and/or you are feeling sick with fever and/or cough please stay home.

For your protection, all staff and patients are screened for any signs of infection including temperature readings. Patients and staff are required to remove outdoor shoes and use hand sanitizers upon entry into our clinic. Patients will be asked to maintain a safe distance from one another and our clinicians are required to use masks during patient encounters. Hand sanitizers are available throughout the clinic for your use.

Due to the COVID-19 crisis, we have made the decision to close our clinic **temporarily** for **OHIP funded physiotherapy** until **April 4, 2020**.

We will reopen Monday April 6, 2020. During our closure we will still be accepting referrals from your physicians and individual requests for registration by fax or email. Once requests are received you will be placed in a cue and notified for registration immediately upon our return.
